Privacy

- “The right to be left alone”
- Louis Brandeis
- recommended reading: “The Right to Privacy”
Alderman and Kennedy (1995)

Obligations to others

“What you see here, what you hear here,
when you leave here, let it stay here”
- Alcoholics Anonymous

- customers
- colleagues
- superiors

Technology can be very invasive

- Lower Merion School District laptop camera case
- web browsing
- electronic mail
- electronic diaries
- repair technicians
- disposal/destruction

Ethics – “Just Say No”

- Do not gossip
- Make sure bounds are proper
- Get instructions from superiors **IN WRITING**
- Heed your conscience

Medical Data

- Patient privacy
- You do not know what is sensitive; even the mere fact of a visit
- aggregation

Investigations

- germane
- relevant
- character assassination
- cases
 - Consultant on litigation
 - investigation of 3rd party computer
 - information private to consultant unless matches agreed criteria

Information Gathering

- Transactional data
- Can disclose other information
- Can be misconstrued
- Often less than it seems
 - E-Z Pass
 - Cell phone records
 - bankcard transaction records

Information explosion is an ethical challenge

- Much privacy was guaranteed by economic infeasibility
- Connectedness removes this impediment
- Social networking enables lightning fast spread
- privacy over time
 - persistence
 - changing circumstances
 - example: campus newspapers & online

An evolving area –

- Generation Y/Millennials
- long term impact of search engines
- the “infinite memory world”;
“somewhere out there”;
there is a copy of something which may
later become embarrassing

Conclusions –

- Be careful; the landscape is evolving
- Think long term consequences
- Consequences can be severe
